#### **Ability Focus Roscommon Project**

Roscommon LEADER Partnership, in collaboration with the Brothers of Charity Services Roscommon, Youth Work Ireland Roscommon/NE Galway, Regari Recovery College, Roscommon County Council and the Irish Congress of Trade Unions, has been granted funding under the Dormant Accounts funds to provide support for young people 15yrs to 24yrs with Disabilities, including Autism. The project focuses on individuals abilities, with the aim of supporting young people with disabilities (including autism) to make the transition from school to further education and training, and to improve participants employability prospects.

The **Ability Focus Roscommon Project** will link training to work; improve motivation, build confidence and enhance personal skills, through the provision of QQI certified programmes, including a two week work experience placement designed to guide participants in the most appropriate direction to allow realisation of their individual ambitions.

The project is an exciting new initiative which will empower the participating young people, their families and care givers to focus on abilities, perceptions, norms and behaviours thus assisting and promoting positive capacity building.

All participants will be supported to identify their skills and abilities through guidance, mentoring and goal setting supports. The methods used during the programme will build the capacity of the participants to become effective communicators and confident goal-focused individuals.

#### **Roscommon Friendly Call Service**

LAUNCHED in October 2008, the Roscommon Friendly Call Service has gone from strength to strength over the past number of years and provides an innovative and unique service to County Roscommon's older community. Operated by Roscommon LEADER Partnership and staffed by trained volunteers and workers, the Friendly Call Service provides a weekly phone call to clients and provides social contact for at times, a forgotten generation.

Roscommon Friendly Call Service provides a free telephone support service to the clients making a phone call to each client once or twice a week to ensure their well-being, have a quick chat and/or also to remind them of hospital and doctors appointments if needed, etc. There are currently 6 volunteers and one part-time worker who have had training in communication skills and computers. The volunteers who operate the service are senior citizens, who have plenty in common with the clients and understand issues concerning older people living in County Roscommon. This is a free and innovative service which is being currently used by over 150 clients.

The Friendly Call Service works towards improving and protecting social living standards, and very importantly in reducing the feeling of isolation often experienced by people living in rural areas. The service is fully supported by public health nurses around the county who engage with older people, and they encourage people to avail of the service.

The Friendly Call Service also acts as an emergency action service. In the event of there being no response to the call by the client, the friendly call service volunteer will contact a next of kin to check on the clients well-being before contacting emergency services if it is deemed necessary.

#### Save Roscommon Campaign

Roscommon LEADER Partnership is an enthusiastic supporter of the Save Roscommon Campaign, which is aimed at preventing the planned annexation of the Monksland area of south Roscommon to Co. Westmeath.

Roscommon LEADER Partnership has been a leading player in the delivery of services and funding to the business, community and voluntary sector throughout Co. Roscommon for over 20 years. Over this period, RLP has developed vast experience dealing with all sectors of the community throughout Co. Roscommon, under the various schemes and programmes operated by us. RLP has grave concerns that the relationships, trust and experience built up would be lost to the Monksland area should the proposed boundary change take place.

RLP also has fears about the effects of a reduction in the population of Co. Roscommon. These could include less funding available under schemes and programmes, which would in turn have a knock-on effect on job creation, rural isolation, deprivation, etc.

RLP will continue to work with the Save Roscommon Committee in order to protect the Roscommon county boundary.





#### Roscommon Native scoops Major Award for RTE programme featuring Roscommon

A Roscommon native has recently won a major award for a television programme which focused on tourism in Co. Roscommon and featured a number of projects and promoters who have been supported by Roscommon LEADER Partnership. The programme also featured RLP directors, staff and volunteers.

The Travel Extra Travel Journalist of the Year - Broadcasting Award was presented to Mary Fanning, a native of Knockvicar, who directed the RTE programme 'Nationwide' which showcased the wide variety of tourism attractions on offer throughout Co. Roscommon.

Presented by Mary Kennedy, the programme was recorded and broadcast in September 2015 and visited the Lough Gara Lake & Legend's tour, Rathcroghan and Owennagat cave, Elphin Windmill, Boyle Abbey, King House, Lough Key Forest Park and Castlecoote House.

The Erasmus+ Youth Enterprise through Arts is a dynamic project to encourage and support young entrepreneurs in the field of Cultural Creative Industries. YEA will find new ways to integrate high quality entrepreneurship education into existing youth services and structures by training youth workers.



For Roscommon LEADER Partnership, one of the first steps in this process was to meet with and plan the 22 month long project with our Partners Organisation. This meeting took place and was facilitated by the Project Lead Partner Dungannon Enterprise Centre in Northern Ireland. RLP also met the other partner organisations from BEAM UK(NI), Herve and Cyrielle from Musiques de Nuit in France and Antoine from VisMedNet Association in Malta and Orla from Momentum in Leitrim . The team then began to plan working collaboratively to develop a Training Programme for young people to learn skills to establish Enterprises through the Arts.

The follow on step from this was to establish a Regional Alliance in Co Roscommon. Its main aim is to bring all the main stakeholders from the Art, Enterprise and Youth sectors together to map out where the services were operational and to get their input into conducting a small scale SWOT analysis of the region to help inform the development of resources, toolkit and course curriculum for delivery to Young People in the Youth Enterprise through Arts Project. The second Regional Alliance Meeting took place on Thursday, 25<sup>th</sup> February in Roscommon.

#### **WARMER HOMES SCHEME**

The Warmer Homes Scheme (WHS) is funded by the Sustainable Energy Authority of Ireland (SEAI) to install energy efficiency improvements in the homes of the elderly and vulnerable, making the homes more comfortable, healthier and more cost effective to run.

The service involves the installation of standard energy efficiency measures appropriate to the eligible household, subject to a house (building) survey, budget allocation and available capacity. The service is provided at no cost to the household and the measures currently available under this scheme are:

- Attic insulation
- Lagging jackets
- Draught proofing Low energy light bulbs
- Cavity wall insulation
- Ventilation
- Energy advice
- BER

The WHS is available to homes which meet the following criteria:

- Owner occupied non-Local Authority homes
- Constructed before 2006
- The owner is in receipt of one of the following
  - Fuel Allowance as part of the National Fuel Scheme
  - Job Seekers Allowance for over six months and with children under 7 years of age
  - Family Income Supplement
  - One Parent Family Allowance

#### **Project Match Castlerea**

Roscommon LEADER Partnership, through SICAP, is working closely with Project Match in Castlerea. Project Match Castlerea is a community initiative which uses the skills and talents of local residents, the support of local agencies and all available resources to build a safe and healthy community for all. An element of Project Match that was focused on this year was to carry out a needs analysis on young people in Castlerea and their experiences of the town they live and socialise in.

Following on from this research, the young people from Transition Year were invited to present the research to the newly established Towns Team in Castlerea and the Chief Executive of Roscommon County Council, Eugene Cummins, in collaboration with Castlerea Community School and with support from the Transition Year Co-ordinators Eileen and Julie.

This was a great opportunity for the young people to get their voices heard at a local level. The young people prepared the Powerpoint Presentation from the research, picking out issues that were most relevant to them; issues that they felt the Town Teams Committee could assist and support them with. The two main themes that were presented were the need to promote awareness of mental health and wellbeing of Young People and also their need to have a Social Space where they could hang out with friends off the streets.

The Young People then made recommendations on how they could work together with the community and Town Teams for the betterment of Castlerea. One recommendation was to arrange Darkness into Light walk in the town. This was very important to the Young people as they felt it would bring the community together in a positive way. It would also highlight and include the healthy aspect of walking, which promotes health and wellbeing, as well as addressing the issue that came out in the research that the Demesne in Castlerea was unsafe. The young people felt that having the walk through the Demesne would show people what a nice area it was. The Darkness into Light walk is scheduled to take place on May 7<sup>th</sup> at 4:30am from Castlerea Enterprise Hub. #### **Business Planning**


Business planning training consists of group and one-to-one training sessions that mainly cover market research techniques, marketing strategies and financial projections. The outcome from this training is a completed business plan.


#### Introduction to Bookkeeping
