RLPs current responsibilities include the delivery of the Rural Development Programme (LEADER) and the Social Inclusion Community Activation Programme (SICAP). A number of other initiatives, funded by various Government Departments and Agencies/Bodies in Ireland and EU are also delivered by the company, including the Rural Social Scheme, TÚS, Warmer Homes Scheme and the Traveller Health Initiative. Roscommon LEADER Partnership has a very broad remit, having a role in such diverse subjects as tourism, enterprise, environment, recreation, social inclusion and assistance to the unemployed to name but a few.

LEADER Programme 2014–2020: Update

In May 2015, Roscommon Local Community Development Committee (LCDC), a committee

of Roscommon County Council, in conjunction with Roscommon LEADER Partnership, submitted an Expression of Interest for the new LEADER Programme (LEADER 2014 – 2020) to the Dept. of Environment, Community & Local Government. This Expression of Interest has been successful and RLCDC, RCC and RLP are now proceeding to draw up the Local Development Strategy (LEADER Plan) for County Roscommon. The LDS will be submitted to the Dept. by the end of September 2015 and it is hoped that the new LEADER Programme 2014-2020 would be up and running in Co. Roscommon before the end of the year.

Roscommon LEADER Partnership continues to accept LEADER Project Proposals (Expressions of Interest) for the LEADER Programme 2014-2020. Forms can be downloaded from our website – www.rosleaderpartnership.ie.

Town Teams Public Meetings

Recently, Town Teams public meetings were held in Ballaghaderreen, Boyle, Castlerea, Monksland, Roscommon Town and Strokestown. Town Teams Committees have been set up in each of the 6 towns. Plans are now underway to appoint a Facilitator to work with the new committees to develop Town Teams Plans. Town Teams is a collaborative approach to identifying priorities within towns and planning for towns' future. The approach will encompass all aspects of economic and social life in each town.

WARMER HOMES SCHEME



The Warmer Homes Scheme (WHA), funded by the Sustainable Energy Authority of Ireland (SEAI), funds energy efficiency improvements in the homes of the elderly and vulnerable, making the homes more comfortable, healthier and more cost effective to run.

The service involves the installation of standard energy efficiency measures appropriate to the eligible household, subject to a house (building) survey, budget allocation and available capacity. The service is provided at no cost to the household and the measures currently available under this scheme are:

- Attic insulation
 - Draught proofing
- Lagging jackets
- Low energy light bulbs
- Cavity wall insulation
- Energy advice
- Ventilation
- BER

The WHS is available to homes which meet the following criteria:

- Owner occupied non-Local Authority homes
- Constructed before 2006
- The owner is in receipt of one of the following
 - Fuel Allowance as part of the National Fuel Scheme
 - Job Seekers Allowance for over six months and with children under 7 years of age
 - Family Income Supplement

The aim of the Social Inclusion and Community Activation Programme is to reduce poverty and promote social inclusion and equality through local, regional and national engagement and collaboration. Its vision is to improve the life chances and opportunities of those who are experiencing forms of marginalisation in society, living in poverty or in unemployment through community development approaches, targeted supports and interagency collaboration, where the values of equality and inclusion are promoted and human rights are respected.

The individuals assisted will include the most vulnerable in society who are unable or unlikely to access mainstream supports. The following are the groups to be engaged in SICAP services:

- Children and families
- Lone parents
- New communities (including refugees/asylum seekers)
- Disadvantaged communities
- People with disabilities
- Travellers
- Roma

- The Unemployed (including those not on the live register)
- Young unemployed people

The Rural Social Scheme (RSS)

The Rural Social Scheme, benefits farming families offering a supplementary income to farming. It gives the opportunity of employment in rural areas where jobs are few. The main benefit of this employment scheme for farmers is that it is part time, thus allowing, within reason, flexible time for both farming and employment.

The Rural Social Scheme also impacts greatly on life within Co. Roscommon – for example, RSS Participants are involved in projects relating to tourism; pride of place; village enhancement; rural enhancement; information/visitor centres; heritage; village/rural development; walks; social care; assisting the elderly with small tasks in and around their homes. Participants also work with voluntary organisations whose remit it is to assist other groups with networking opportunities and organise volunteering opportunities. This role also includes the dissemination of information on agencies and schemes operating with the county and the types of funding available to community and voluntary groups.

Other benefits to this very valuable scheme are;

- It provides participants with a social outlet, offering the opportunity to get out and interact with other people on a regular basis.
- The scheme helps to address isolation. This is an important contributor to building the confidence and self esteem of participants.
- It has a significant impact on additional income earned giving an increased cash-flow to participant households.

The voluntary activity undertaken by the members of the sponsor committees has been complemented and supplemented by the skills and experience that RSS participants can bring to many initiatives such as walks, stone wall building, Golden Mile, Care and Repair, gardening, general maintenance and many other projects which helps to secure recognition for communities and community effort encouraging a mix of voluntary and RSS input.

At present, there are approximately 2,600 participants nationally on the Rural Social Scheme and 130 Supervisors; Co. Roscommon has 149 participants and 7 Supervisors.

TÚS Programme

TÚS is a Community Work Placement Scheme providing short-term working opportunities for the long-term unemployed. It started in 2011 in Roscommon and is implemented by Roscommon LEADER Partnership on behalf of Dept. of Social Protection. There are approximately 8,000 places nationwide, with 140 placements in County

Roscommon.

TÚS participants spend 1 year working 19.5 hours per week for a local community group, while still maintaining all their social welfare entitlements. In general, DSP chooses TÚS participants by way of a random selection of those who are signing on for Jobseekers

Allowance for 12 months or more, but a limited number can also be self-referrals (contact RLP for more details).

The objectives of TÚS are to provide work and training opportunities for those who are long-term unemployed, as well as providing income support for those on social welfare payments. TÚS is also a great way to harness the skills and talents of participants to benefit local communities.

The types of work undertaken under TÚS include:

- Childcare and Social Care
- Caretaking, securing, supervising of community buildings and spaces
- Renovation of community and sporting facilities
- Cultural and Heritage activities
- Community administration and community event management
- Town and Village enhancement
- Retail Services in Charity Shops
- Energy Conservation

Active Citizenship & Politics - FETAC Level 6

Are you a member of a community group? Or are you interested in establishing a community group or organisation? Do you want to help make a change to your own situation and that of others or locally within your community? Do you want to be listened to?

If so, this course may be for you....

It will help you identify how best you can engage in citizenship and how you can influence decision makers!

Roscommon LEADER Partnership, in conjunction with Roscommon County Council, is offering community leaders and activists the opportunity to build their skills, and affect real change by funding Active Citizenship Training.

What will you learn?

- What Active Citizenship is & how Political Systems work
- It will provide you with the confidence to engage effectively as leaders and to help create change
- It will support you to work through conflict within groups
- It will teach you how to engage in the decision-making process at various levels
- It will provide an understand political ideologies, power and how we live as citizens
- And it will provide the 'How to' of lobbying, its process and purpose

This course will begin in early Autumn in Roscommon LEADER Partnership Offices, Roscommon Town, one evening per week for 7 weeks and one full Saturday (this may be subject to change based on consultation with course participants).

Non Accredited Training for potential Back to Work Enterprise Allowance Clients (BTWEA)

Need

- Need highlighted when 77 people attended 6 self employment workshops held throughout County Roscommon during April & May 2015
- Long-term unemployed setting up enterprises need training and mentoring supports
- Tailormade specialist training and mentoring that helps to build confidence in the long-term unemployed who want to set up enterprises
- Main needs are around enterprise feasibility for pre-enterpise clients and business planning training for those preparing to go on the Back the Work Enterprise Allowance Scheme
- Completion of a business plan is a requirement for going on the Back to Work Enterprise Allowance Scheme

Training & Mentoring Courses

Could I be my Own Boss? This training course is targetting at the pre-enterprise stage. Participants are mentored & trained in how

to appraise and evaluate their enterprise ideas with regard to the potential viability of their projects.

<u>Business Planning</u>
Business planning training consists of group and one-to-one training sessions that mainly cover market research techniques, marketing strategies and financial projections. The outcome from this training is a

completed business plan.

Introduction to Bookkeeping Back to Work Enterprise Allowance clients are introduced to basic bookkeeping skills.

The above training and mentoring courses are provided when a suitable number of participants can be identified. Potential Back to Work Enterprise Allowance clients are also referred to a wider choice of training and mentoring options that can add further value through the Local Enterprise Office.
